Such evidence would include, for example, letters testamentary, letters of administration, or a copy of the trust documents.)

I further state that I believe in good faith that:

- I may be a Settlement Class Member; and
- I am not a Defendant in the litigation that is the subject of this settlement or anyone excluded from the Net Settlement Fund; and

No discovery shall be allowed on the merits of the litigation or settlement in connection with processing of the Proofs of Claim.

I agree to furnish additional information (including transactions in other DELL securities) to the Claims Administrator, if requested to do so.
